\*Rebate applies to all ACDelco passenger car, light duty truck, heavy-duty and 60-Series Marine batteries - Professional Voyageur, motorcycle and Power Sport batteries do not qualify for the rebate. Rebate open to all Canadian Independent Service Centres (ISC) ONLY that have purchased the batteries from an authorized GM Canada authorized full line warehouse distributor, for use in Canada.

Rebate applies to minimum of 10 batteries purchased during the promotion period from an authorized GM Canada authorized full line warehouse distributor, for use in Canada. Maximum of 150 batteries per ISC eligible for rebate.

Please allow 6-8 weeks from end of promotion for redemption and receipt of your funds. Funds will be transferred to Total Service Support members as Exclusively Yours Bonus points on their EY card – to the account holder on record (any account with 2 cards, the funds will be split) and on the Real Rewards AMEX card for those who are not TSS members and are qualifying Independent Service Centres. One Real Rewards AMEX point or one EY point has the value of one Canadian dollar. Cards will be sent to the person's name included on this redemption form and/or the name attached to the EY or Real Rewards cards on file. However, the rebate provided under this program is made by ACDelco to the Independent Service Centre and liability (if any) for withholding, reporting or payment of any applicable Federal, Provincial, GST or other sales, Income Tax or Payroll Tax is the responsibility of the Independent Service Centre and not ACDelco (General Motors of Canada Limited). The Independent Service Centre is the entity that assigns the rebate to the individual participants in its discretion and the responsibility for preparing/issuing T4/T4A information slips to those individuals upon whom a benefit may be conferred rests with the Independent Service Centre. Acceptable proof of purchase documentation includes: 1). Original or photocopied Distributor invoices, or 2). Computer-generated Distributor summary reports that must include the Distributor and the ISC name, addresses, invoice number and purchase date, ACDelco battery part number, purchase price and quantity of batteries purchased. All rebate forms are subject to audit. GM Dealers, Jobbers and ACDelco Distributors are not eligible for this rebate. ACDelco reserves the right to modify or cancel this promotion at any time, for any reason. ACDelco is not responsible for late, lost or destroyed submissions.

Only batteries purchased by Canadian Independent Service Centres from a qualifying Full Line Canadian ACDelco Distributor, made between April 15 and May 15, 2009, qualify. Incomplete, illegible entries, or entries received after May 31, 2009 will not be accepted. Backordered batteries, returned batteries or batteries provided free of charge from the distributor do not qualify for a rebate. Minimum purchase of 10 qualifying batteries per redemption.
